# DATA PROTECTION POLICY OF CROWE ENOFIN WEB APPLICATION

Effective Date: 1 June 2021

This Web Data Protection Policy ("Policy") describes how Crowe Horwath First Trust Outsourcing Pte Ltd ("Crowe SG") collects, processes, uses and discloses information through your use of Crowe enoFin Web Application (the "Web").

This Policy does not apply to our collection of data through our websites other than those web pages accessed directly by the Web.

#### Purposes for the Collection and Use of Your Personal Data

The following personal information may be collected through your use of the Web:

- · Your name, national identity card number or passport number
- · Your contact information such as address, phone number, fax and email

The following non-personal information may be collected through your use of the Web:

- Date and time when the Web accesses our server
- Information that has been downloaded to the Web
- The version of the Web that you are using

Your personal data is processed by us to give effect to your requested commercial transaction, including the following:

- Authenticate you on the Web so that you can access your account via the Web
- To provide our accounting services
- To maintain contact with you
- To respond to your request or for the purpose for which it was provided to us as stated at the time of collection
- For general management and reporting purposes such as dissemination of statements

#### **Disclosure of Personal Data**

We respect the confidentiality of the personal data you have provided to us. Your personal data provided to us is processed by Crowe SG and its affiliates (in or outside of Singapore) in order to meet the purposes for which you have submitted the information.

By submitting personal data to us, you are providing explicit consent to trans-border transmission of such data as described in this Policy. We will ensure that any transfer of personal data to a territory outside of Singapore will be in accordance with the Singapore's Personal Data Protection Act 2012 ("PDPA") so as to ensure a standard of protection to personal data so transferred that is comparable to the protection under the PDPA.

# **Disclosure of Personal Data (continued)**

### **Access and Update to Personal Data**

## **Administration and Management of Personal Data**

We have put in place reasonable security arrangements to ensure that your personal data is adequately protected and secured. Appropriate physical, electronic and procedural safeguards have been taken to prevent any unauthorised access, collection, use, disclosure, copying, modification, leakage, loss, damage and/or alteration of your personal data. However, we cannot assume responsibility for any unauthorised use of your personal data by third parties which are wholly attributable to factors beyond our control

We have also put in place measures such that your personal data in our possession or under our control is destroyed and/or anonymised as soon as it is reasonable to assume that (i) the purpose for which that personal data was collected is no longer being served by the retention of such personal data; and (ii) retention is no longer necessary for any other legal or business purposes.
